I understand by signing this agreement I am giving my permission for my vendor information and pictures taken at market to be displayed on the Downtown Houghton Farmers Market, City of Houghton, Downtown Houghton websites, Facebook and to be linked into other sites unless explicitly requested otherwise.

Waiver of Liability and Hold Harmless Agreement

Those persons, employees, partners, family and their guests who vend/attend the Downtown Houghton Farmer's Market in the City of Houghton, Michigan, understand and agree that they do so entirely at their own risk. The City of Houghton and its employees, including the Downtown Houghton Farmer's Market Manager and Market Advisory Board, are not responsible for personal injury or loss of personal property due to fire, theft, collision, vandalism or negligence. Vendors, employees, partners, family and their guests hereby waive all claims against the City of Houghton, and the Downtown Houghton Farmer's Market for any personal injury or property damage in, upon or about the market/city premises. Further, vendors, employees, partners, family and their guests agree to hold the City of Houghton and its employees, including the Downtown Houghton Farmer's Market Manager and Market Advisory Board, harmless from any claims for damage and/or injury to a person arising from the use of the market by the vendor, employees, partners, family and their guests, however caused. Vendors agree that the City of Houghton and its employees, including the Downtown Farmer's Market Manager and Advisory Board are not responsible to the vendor, employees, partners, family and their guests, for any personal injuries suffered or personal property loss due to theft, fire, negligence or other cause.
